Just as we're putting the polishing touches on this year's Annual Report, our contractors are finishing up the electrical, piping and miscellaneous work necessary to get our cannery operational! All the equipment is in place and ready to go. In just a matter of weeks, we'll flip the switch.

For more than two years, we've been telling you about this project and how it will help us better serve those in need in our community with vocational training and life skills development programs. Today, we expect to have our first enrollees going through the 6-month program in March. It's an exciting time for all of us at COMPA Ministries and we certainly couldn't have done this without the faithful support of our many donors and volunteers.

Beyond the cannery, we've completely revamped our Farm Market model, instituting processes and procedures that help us better track and distribute fresh produce to our 140 hunger relief partners. They, in turn, serve more than 70,000 individuals each week. We also completed our vacu-seal operations and have begun packaging beans and flash frozen vegetables that are distributed to those in need.

Without you, none of this would have been possible. Thanks for your continued partnership. More blessings are sure to come in 2010!

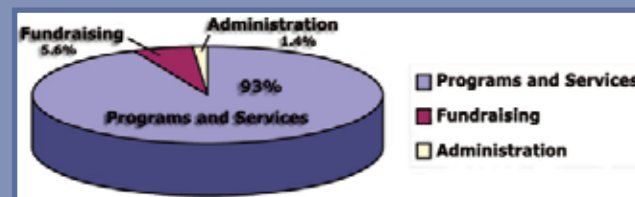

### Highlights from this past year...

- Started multi-million dollar construction project on new cannery, scheduled to be completed March 2010.
- Completed construction on full-production vacu-seal operations and have begun packaging operations with navy beans.
- First time in the history of COMPA, we secured out-of-home media placements (billboards and bus shelter posters) throughout Denver metro area.
- Completely revamped our Farm Market program as part of overall commitment to leveraging efficiencies and implementing strict processes and procedures.

## Our Programs

### Vocational Training

On-the-job positions include raw materials production, canning line operators, packaging line operations, general warehouse labor, forklift operation, Farm Market attendant and more

Training provides participants with real-world experience they can use to get full-time employment

By-product of job training programs is the healthy, nutritious food that is provided to the community through various hunger relief agencies

### On Track

Classroom-style life skills training that equips program participants with the skills and attitudes needed to succeed in today's job market. Sessions teach basic life skills necessary to reach a given level of self-sufficiency.

Primary tracks cover topics such as personal care and health issues, social skills development, communication, job retention and individual finances. Secondary tracks focus on vocation-specific skills and certifications, while optional tracks allow for personal or spiritual development.

### Farm Market

An innovative system designed to distribute perishable food items through a "next-day" system to help hunger relief agencies distribute good and fresh produce in a timely manner.

The Web-based system provides a selection and organization mechanism to ensure registered member agencies get acceptable quantities of available food on a daily basis. Registered member agencies are able to match their needs and distribution methods with produce availability on daily basis

### Project Glean

During harvest season, volunteers harvest produce that is then donated to COMPA and distributed to hunger relief agencies in the community or vacuum sealed and stored for future distribution.

Provides Colorado-grown fresh, nutritious produce for immediate distribution or storage and typically takes place on weekends during harvest season (September and October). Great outreach effort for businesses, youth groups, churches, families, or others

More than 93 cents of every dollar donated to COMPA Ministries goes directly to supporting our programs and clients.
